### **PAYMENT OF BASE FEE TO REGAL PORTFOLIO MANAGEMENT LIMITED BY WAY OF UNITS IN REGAL REAL ESTATE INVESTMENT TRUST**

The Board announces that on 14th April, 2010 the REIT Manager received 2,069,317 new Units issued at the price of HK\$1.732 per Unit (being the Market Price) and 1,839,326 new Units issued at the price of HK\$1.760 per Unit (being the Market Price) (representing, in aggregate, approximately 0.122% of the 3,212,709,253 Units in issue immediately after such issue) as payment in full of the related Base Fee of HK\$3,584,058.13 and HK\$3,237,213.79 for the periods from 1st January, 2010 to 31st January, 2010 and 1st February, 2010 to 28th February, 2010, respectively. The REIT Manager held 71,751,019 Units before the receipt of the new Units. With the new Units issued, the REIT Manager presently holds 75,659,662 Units (representing approximately 2.355% of the 3,212,709,253 Units in issue immediately after such issue).

The Board announces that on 14th April, 2010 the REIT Manager received 2,069,317 new Units issued at the price of HK\$1.732 per Unit (being the Market Price) and 1,839,326 new Units issued at the price of HK\$1.760 per Unit (being the Market Price) (representing, in aggregate, approximately 0.122% of the 3,212,709,253 Units in issue immediately after such issue) as payment in full of the related Base Fee of HK\$3,584,058.13 and HK\$3,237,213.79 payable by Regal REIT to the REIT Manager for the periods from 1st January, 2010 to 31st January, 2010 and 1st February, 2010 to 28th February, 2010, respectively. The basis of determination of the new 3,908,643 Units as payment of the related Base Fee is consistent with the relevant provisions of the Trust Deed. The REIT Manager held 71,751,019 Units before the receipt of the new Units. With the new Units issued, the REIT Manager presently holds 75,659,662 Units (representing approximately 2.355% of the 3,212,709,253 Units in issue immediately after such issue).

The Variable Fee is payable annually and the Variable Fee for the financial year ended 31st December, 2009 will be paid by Regal REIT to the REIT Manager after the audited financial accounts of Regal REIT for such financial year are published. Details regarding the Variable Fee have been disclosed in the Offering Circular.

The payment of the Base Fee by way of Units is in accordance with the terms of the Trust Deed and does not require specific prior approval of the Unitholders pursuant to a waiver granted by the SFC. Principal provisions regarding the Base Fee have also been set out in detail in the Offering Circular.

The waiver in respect of payment of REIT Manager's fees by way of Units was granted by the SFC on the condition that:

- (1) the issue of Units to the REIT Manager as payment of all or part of the Base Fee and/or Variable Fee for each financial year will be counted as part of the 20% of outstanding Units that the REIT Manager may issue in each financial year without the approval of Unitholders pursuant to paragraph 12.2 of the REIT Code;
- (2) in respect of each financial year, the maximum number of Units that may be issued to the REIT Manager as payment of all or part of the Base Fee and/or Variable Fee for that financial year shall be limited to such number of Units which represents 3% of the total number of Units outstanding as at the last day of the immediately preceding financial year plus the number of Units (if any) issued in the relevant financial year for the purpose of financing any acquisition of real estate by Regal REIT;
- (3) any issuance of Units to the REIT Manager as payment of all or part of its Base Fee and/or Variable Fee shall be made strictly in accordance with the requirements of the Trust Deed; and
- (4) in the event that any payment of all or part of the Base Fee and/or Variable Fee in the form of Units to the REIT Manager exceeds the relevant thresholds set out in paragraph 12.2 of the REIT Code and paragraph (2) above, and Unitholders' approvals is not obtained for the issue of Units for such purpose, then payment of that excess part of the Base Fee and/or Variable Fee will be made by Regal REIT to the REIT Manager in cash.
